

## Publication of your Bachelor and Master Theses in the Digital Repository

Theses awarded with the university prize as well as excellent theses with a grading of 1.0 to 1.7 and with sustained professional relevance can be published at the BTU Digital Repository (OPUS).

Furthermore articles created from final theses can be published through the green way of Open Access at the Digital Repository.

1. Before submitting your thesis, please clarify all copyright and licence-related questions to ensure that the publication is free of any third party rights. If you plan to publish your thesis additionally with a publishing house, they must agree to the electronic publication by the University Library. Please check your thesis for possible non-disclosure-notice. If your thesis has been developed in cooperation with a company, the company must agree with the electronic publication by the library as well if there is no non-disclosure notice.

2. Reference management tools help you to keep track of large quantities of literature and make it easier for you to quote correctly and create bibliographies. The university library provides a campus licence for Citavi for free.

3. Please use the PDF/A-1b format for the file you create from your document.

4. Transfer the metadata (such as abstracts in German and English with a maximum of 3.000 characters each as well as 5 keywords in German and English) and the PDF/A file to the BTU Digital Repository. If your thesis is written in English, please include the title and abstract in German as well. To publish your thesis, please use the registration form and select „Bachelor thesis“ or “Master/Diplom” as document type.

5. The Thesis Office will examine the metadata and files and will inform you afterwards if everything is complete and correct. With this e-mail the Thesis Office will ask you to check your entry in OPUS and asks you to inform the department about possible changes.
6. At the bottom of the first page of the registration form a link to the Declaration of Consent will be provided. Please read this declaration carefully and complete the form. Afterwards submit the original declaration form, signed by you and your supervisor, to the University Library.
